

# Philippines Offer Terms and Conditions

## 1. Introduction

- (a) The Philippines August 2025 OET Test Sale (**Offer**) is provided by Cambridge Boxhill Language Assessment Pty Ltd (ACN 159 885 257) as trustee for the Cambridge Boxhill Language Assessment Unit Trust, of PO Box 16136, Collins St West Melbourne VIC 8007 Australia (**we, us or our**).
- (b) By claiming the Offer, you accept these Terms and Conditions.

# 2. Offer Period

- (a) The Offer opens at 12:00am PHST on 1 August 2025 (2.00am AEST 1 August 2025) and closes at 11:59pm PHST on 30 September 2025 (1.59am AEST 1 October 2025) (Offer Period).
- (b) We may modify, terminate or extend the Offer Period at any time, subject to applicable laws.

# 3. Offer

(a) The Offer is applicable for all 12 test professions on two delivery modes:

## **OET Test on Paper (PBT)**

For available test dates for all OET Test on Paper full tests in the Philippines between 2 October 2025 and 31 December 2025 (**Test Period**) that are open for registration during the Offer Period. Bookings are subject to availability. At the time of booking, you must enter the discount code **OETPH38** to receive the discounted price of AU\$360. If you do not enter the discount code, you will be charged the full price.

OET Test on Paper booked at the discounted price cannot be rescheduled. To change your booking to a different test date, you must cancel your discounted booking, pay the cancellation fee, and book a new test.

#### **OET Test on Computer (CBT)**

For available test dates on all OET Test on Computer full tests in venue in the Philippines that are open for registration during the Offer Period. Bookings are subject to availability. If you book during the Offer Period, the cart will **automatically apply** the discounted price of AU\$360 when booking an OET Test on Computer to be taken in venue in the Philippines.

OET Tests on Computer booked at the discounted price can be rescheduled by paying the associated rescheduling fee.

- (b) The Offer is not available for OET at Home.
- (c) To claim the Offer, you must, during the Offer Period:
  - (i) book and pay for OET Test on Paper and/or OET Test on Computer via the OET website <a href="https://oet.com/test/book-a-test">https://oet.com/test/book-a-test</a>, with the test to be completed at an OET test venue in Philippines; and
  - (ii) not be employed by, or contracted to, us or our affiliates (or be a family member of such a person).
- (d) The Offer cannot be used in conjunction with any other offers, promotions or discount codes.
